# **Arlington National Cemetery**

The latest innovation at the cemetery is an interactive map available through the Cemetery's website (<a href="www.arlingtoncemetery.mil">www.arlingtoncemetery.mil</a>) and a free smart phone app, uses geospatial technology to locate graves. Users can search for specific graves and see the Veteran's dates of birth and death plus photos of the front and back of the headstone. The smart phone app guides user's right to the grave they are searching for, and can be downloaded at the Cemetery's visitor center.
